- 2. This bidding will be conducted under National Competitive Bidding Procedure.

Interested bidders may obtain further information from the Deputy Controller (Procurement), Procurement Division, 05<sup>th</sup> Floor, Department of Immigration and Emigration, "Suhurupaya", Sri Subhuthipura Road, Battaramulla and inspect the Bidding Documents at the same address from 9.00 a.m. to 3.00 p.m. on any working day from 20.06.2024 to 09.07.2024.

A complete set of printed bidding documents may be obtained on submission of a written application to the Deputy Controller (Procurement), Procurement Division, Wing "B", 05<sup>th</sup> Floor, Department of Immigration and Emigration, "Suhurupaya", Sri Subhuthipura Road, Battaramulla from 9.00 a.m. to 3.00 p.m. on working days from **20.06.2024 until 09.07.2024** upon payment of a non-refundable fee of Rupees Five Thousand Five Hundred (Rs.5,500.00). The mode of payment is in cash.
- 5. Completed bids in two copies as "Original" and "Duplicate" shall be hand delivered or sent by registered post to the Chairman, Department Procurement Committee, Wing "B", 05<sup>th</sup> Floor, Department of Immigration and Emigration, "Suhurupaya", Sri Subhuthipura Road, Battaramulla to reach at or before 2.00 p.m. on 10.07.2024. Bids will be opened at the aforesaid address immediately after closing the invitation of bids in the presence of the representatives of the bidders interested to be present at the occasion. Late bids will not be entertained and such bids will be returned unopened.
- 6. Bids presented by the bidder shall be valid for a period of 77 days or any extended period with effect from the last date of accepting bids.
- 7. All bids shall be sent to the address of the Controller General of Immigration and Emigration accompanying a Bid Security as mentioned in the form in Section 3.3 of the bidding document. Bid Security shall be for an amount of Rs. 400,000.00, valid up to **22.10.2024** and it shall be issued by a commercial bank operating in Sri Lanka and approved by the Central Bank of Sri Lanka.
- 8. Pre-bid meeting will be held at 2.00 p.m. on 01.07.2024 at the Procurement Division of the Department of Immigration and Emigration, 5<sup>th</sup> Floor of "Suhurupaya".
